BE IT REMEMBERED that on this 10th day of January, 2023, at 9:00 o'clock a.m. there came on and was held in the City of Rocksprings, Edwards County, Texas, at the Edwards County Courthouse therein, a Regular Open Meeting of the Commissioners' Court of Edwards County, Texas. The Agenda for this Regular Open Meeting of the Commissioners' Court of Edwards County, Texas was posted on January 5, 2023 at 2:06 p.m.

- 1. **Determination of quorum; Call to Order.** The Open Meeting was called to order at 9:00 o'clock a.m. by Judge Shanklin. The Pledge of Allegiance to the United States Flag and to the Texas State Flag were recited. The Court was led in prayer by Commissioner Fry. The roll was then called by Deputy Clerk Franco. All Commissioners were present.
- 2. Open Forum. There were no speakers present for the Open Forum.
- 3. Staff Reports. There were no questions on the staff reports.

- e. Approve and/or discuss the quotes from Snider IT and Southwest Texas Telephone Co. for election security IT services for the Edwards County Clerk's Office as recommended by the Texas Secretary of State. Olga Lydia Reyes. Snider Technology IT Services provided a quote of \$963.71 for their installation/support for Election Security IT services for the Clerk's Office. Southwest Texas Telephone Company provided a quote of \$135.00/router; \$4.00/filter, \$12.00/Service Order Charge; \$70.00/hour for labor. Commissioner Fry made the motion to approve the quote from Snider Technology and SWTTC for election security IT services for the Edwards County Clerk's Office as recommended. Commissioner Smith seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.
- 5. **New Business.** Matt Fry inquired about updating our Subdivision Regulations. This matter, and that of hydrology studies and the protection of our water, will be placed on next month's agenda. Judge Shanklin said that he proposed also

putting on the agenda that Edwards County would, in the future, no longer be approving any subdivision of 80 acres or less. Any subdivision that existed prior to February 2023 would be grandfathered in.

- 6. **Time and Date for Next Meeting.** The next meeting of the Edwards County Commissioners Court is scheduled for the second Tuesday of February, 2023 (February 14, 2023).
- 7. **Pay bills.** Commissioner Graham made the motion to approve the bills; Commissioner Fry seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.
- 8. **Adjourn.** Commissioner Grooms made the motion to adjourn. Commissioner Smith seconded the motion. No Commissioner noting any opposition, the motion carried 5/0. This meeting of the Edwards County Commissioners Court was adjourned at 9:33 o'clock a.m.
