- e. Discuss and Act upon entering into a Memorandum of Understanding with Tarrant County for fleet vehicle Sheriff J.W. Guthrie. Commissioner Reed made the motion to enter into a Memorandum of Understanding with Tarrant County for a fleet vehicle; Commissioner Fry seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.
- f. Discuss and Act upon declaring March 2022 as American Red Cross Month. Judge Shanklin. Commissioner Sweeten made the motion to declare March 2022 as American Red Cross Month. Commissioner Graham seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.
