BE IT REMEMBERED that on this 9th day of February, 2021, at 9:00 o'clock a.m. there came on and was held in the City of Rocksprings, Edwards County, Texas, at the Edwards County Courthouse therein, a Regular Open Meeting of the Commissioners' Court of Edwards County, Texas. The Agenda for this Regular Open Meeting of the Commissioners' Court of Edwards Court of Edwards County, Texas was posted on February 4, 2021.

1. Determination of quorum; Call to Order. The Open Meeting was called to order at 9:01 o'clock a.m. by Judge Shanklin. The Pledge of Allegiance was recited. The Court was led in prayer by Commissioner Reed. The roll was then called by Clerk Reyes. All Commissioners were present.

2. Open Forum. There were no participants in Open Forum.

3. Staff Reports. There were no questions on the staff reports.

4. DELIBERATE, CONSIDER and/or TAKE ACTION ON ANY OF THE FOLLOWING:

a. Prior Minutes.

January 12, 2021. Commissioner Sweeten made the motion to approve the minutes from January 12, 2021. Commissioner Graham seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.

January 15, 2021. Commissioner Sweeten made the motion to approve the minutes from January 15, 2021. Commissioner Graham seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.

b. **Burn Ban.** Commissioner Fry made the motion to leave the status of the burn ban "as is." Commissioner Reed seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.

c. Discuss and Act upon Preliminary Plat for Wild Canyon Ranch Subdivision Phase II – Sam Poorman – Commissioner Matt Fry. Commissioner Fry made the motion to approve the preliminary plat for Wild Canyon Ranch Subdivision Phase II. Commissioner Reed seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.

f. Presentation of U.S. Census Bureau's Community Partnership and Engagement Program. – Lucia Juarez. Ms. Juarez appeared to present the Court with a Certificate recognizing Edwards County as an invaluable member of the 2020 Census Community Partnership and Engagement Program. This certificate was presented in appreciation for the efforts that the County made in making the Partnership Program a success and helping achieve a successful 2020 Census. No further action was taken.

Commissioner Reed made the motion to approve the bids for the purchase of property held in trust by Edwards County that had previously been approved by other taxing entities. Commissioner Fry seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.

h. Discuss and Approval of Application for FuelmanMastercard Fuel Card for Edwards County Sheriff's Department – Sheriff J.W. Guthrie. Judge Shanklin stated that the previous fuel cards in place for the Edwards County Sheriff's Office were going to be closed and that this new FuelmanMastercard fuel card would be going through the Treasurer's office. Commissioner Sweeten had a few questions and Sheriff Guthrie appeared to address same. Sweeten inquired if Constable Maxwell would have access to the fuel card when conducting his prisoner transports for the Sheriff's Office instead of having the fuel come out of his personal budget. Guthrie indicated that allowing Maxwell access to the fuel card was something that could be worked out. Commissioner Sweeten then made the motion to approve the application for the FuelmanMastercard Fuel Card for the Edwards County Sheriff's Department; Commissioner Fry seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.

i. Amendment of Sheriff's Budget on line item 10-500-493 for 47,718.00 for the purchase of a vehicle. – Judge Shanklin.Judge Shanklin addressed the Court. He stated that this check was used in last year's budget. This vehicle was ordered last year. A check for this purchase was previously requested in September 2020 but it was requested in the wrong name. The vehicle has been delivered and a new check will have to be reissued. Because this issue was left over from last year, it was decided that it should be placed on today's agenda. Commissioner Sweeten made the motion to approve the amendment of the Sheriff's Budget on line item 10-500-493 for 47,718.00 for the purchase of a vehicle. Commissioner Graham seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.
