The Agenda for this Regular Open Meeting of the Commissioners Court of Edwards County, Texas was posted on November 7, 2024 at 1:27 p.m.

- 1. Determination of quorum; Call to Order. The Regular Open Meeting was called to order at 9:00 o'clock a.m. by Judge Shanklin. The roll was then called by Clerk Reyes. Judge Shanklin announced that he had a quorum. All Commissioners were present.
- 2. **Open Forum.** There were no participants in the Open Forum.
- 3. **Staff Reports.** There were no questions on the Staff Reports.

- c. Discuss and Act upon Resolution to Apply for FY 2025 CDBG Colonia Fund Construction Pre-Application Carl Esser. Judge Shanklin stated that this grant was for \$750,000.00. Commissioner Smith made the motion to approve the Resolution to Apply for FY 2025 CDBG Colonia Fund Construction Pre-Application. Commissioner Grooms seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.
- c. Discuss and Act upon amending the budget for new IT room at Sheriff's Office. Sheriff James Guthrie. Judge Shanklin stated that the exact cost of this construction is not known. However, there is money to cover these costs and a budget amendment will be needed for this purpose. Commissioner Graham made the motion to approve a budget amendment for the new IT room at the Sheriff's Office; Commissioner Grooms seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.

- f. Discuss and Act upon Resolution for Indigent Defense Grant Program 2025-Judge Shanklin. Commissioner Smith made a motion to approve the Resolution for Indigent Defense Grant Program 2025. Commissioner Fry seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.
- g. Discuss and Act upon Construction and Generator for Kimble County Health Clinic Judge Shanklin. Judge Shanklin announced that this construction would

include things such as redoing the floors, laying paint, constructing a partition wall, and possibly installing a pocket door. Commissioner Fry thought it would be a good idea to get an update on the current status of this building and of the health clinic using it. Judge Shanklin stated that he would ask the health clinic representative from Kimble County to present a status report to the Court. Commissioner Smith made the motion to approve the construction and generator for the Kimble County Health Clinic. Commissioner Fry seconded the motion. No Commissioner noting any opposition, the motion carried 5/0.
