1. **Determination of quorum; Call to Order.** The Open Meeting was called to order at 9:00 o'clock a.m. by Judge Shanklin. The Pledge of Allegiance was recited. The Court was led in prayer by Dr. Todd. The roll was then called by Clerk Reyes. All Commissioners, with the exception of Commissioner Epperson, were present.

2. **Open Forum.** There were no participants in Open Forum.

3. **Staff Reports.** There were no questions on the staff reports.

4. **DELIBERATE, CONSIDER and/or TAKE ACTION ON ANY OF THE FOLLOWING:**

a. **Prior Minutes:** Commissioner Sweeten made the motion to approve the minutes from November 12, 2019; Commissioner Reed seconded the motion. No Commissioner noting any opposition, the motion carried 4/0.

b. **Burn Ban:** The burn ban will be left in place. No further action taken.

- c. **Discuss and Act upon matters regarding FEMA 4416 DR TX – Carl Esser.** Judge Shanklin made the motion to approve the pending matters regarding FEMA 4416 DR TX; Commissioner Fry seconded the motion. No Commissioner noting any opposition, the motion carried 4/0.
- d. **Discuss and Act upon requesting qualifications for professional services associated with preparation of grant applications and program management regarding available funding streams – Carl Esser.** Judge Shanklin stated that this matter will be published in the newspaper and that letters would be sent to contractors.
